


Isometric view




Multiview










ISOMETRIC

All types of connectors	14012	Central Connector, Steel, Slot 10, Nut Vertical to Barrel
<p>Central Connectors Steel, Zinc-Plated</p>   		<ol style="list-style-type: none"> 1. Insert the connector cross-bushing into the bore on the profile. 2. Ensure that the notches on the cross bushing are aligned with the profile centerline. 3. Insert connector pin in the central tube of the profile. 4. Loosen cross-bushing set screw until the pin goes through the cross-bushing. 5. Lightly tighten the set screw to keep the pin from falling out until final assembly.
